Application for rate increase by

Sanlando Utilities Corporation

DOCKET NO. 140060-WS

On July 1, 2014 Sanlando Utilities Corporation (Sanlando) filed a petition with the Florida Public Service Commission (PSC or Commission) for a rate increase. Sanlando serves approximately 10,200 water and 8,400 wastewater customers in Seminole County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Sanlando's rate request, the Commission staff will conduct a customer meeting to allow feedback about Sanlando and the ratesetting process. Customer comments, written and oral, will be taken into consideration before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Sanlando requesting a rate increase?

Sanlando states that it is requesting a rate increase to cover operating costs and earn a fair rate of return on its investment. **3** When was the utility's last rate case? Sanlando's last rate case was filed in 2011 with rates taking effect in 2013.

4 How much are the average monthly water and wastewater bills for a residential customer using 15,000 gallons of water per month?

At the time of filing, the average monthly water and wastewater bills for a residential customer using 15,000 gallons of water per month were \$20.77 and \$32.35 respectively.

5 Using Sanlando's requested rates, how much would the final monthly water and wastewater bills be for a residential customer using 15,000 gallons of water?

Using Sanlando's requested final rates, the water and wastewater bills for a customer using 15,000 gallons of water per month would be \$24.21 and \$36.91 respectively.

6 What if I cannot attend the customer meeting or prefer not to speak? Are there other ways to comment on this case?
