Application for increase in wastewater rates in Charlotte County by

## Utilities, Inc. of Sandalhaven

DOCKET NO. 150102-SU

On June 4, 2015, Utilities, Inc. of Sandalhaven (Sandalhaven) filed an application with the Florida Public Service Commission (PSC or Commission) for a rate increase. Sandalhaven provides service to approximately 835 wastewater customers in Charlotte County.

## QUESTIONS & ANSWERS

# Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Sandalhaven's rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Sandalhaven and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

## **2** Why is Sandalhaven requesting a rate increase?

Sandalhaven is requesting a rate increase in order to recover the cost of operating the utility, including pro forma plant improvements, and allow the company to earn a fair rate of return on its investment.

# When was Sandalhaven's last rate case?

Sandalhaven's rates prior to this rate case were established by Charlotte County in November 2012.

At the time the rate case was filed, how much was the average monthly wastewater bill for a residential customer using 5,000 gallons?

At the time the rate case was filed, the average monthly wastewater bill for a residential customer using 5,000 gallons was \$62.29.

5 Using Sandalhaven's requested rates, how much would the average monthly wastewater bill be for a residential customer using 5,000 gallons?

The average monthly wastewater bill for a residential customer would be \$148.87.

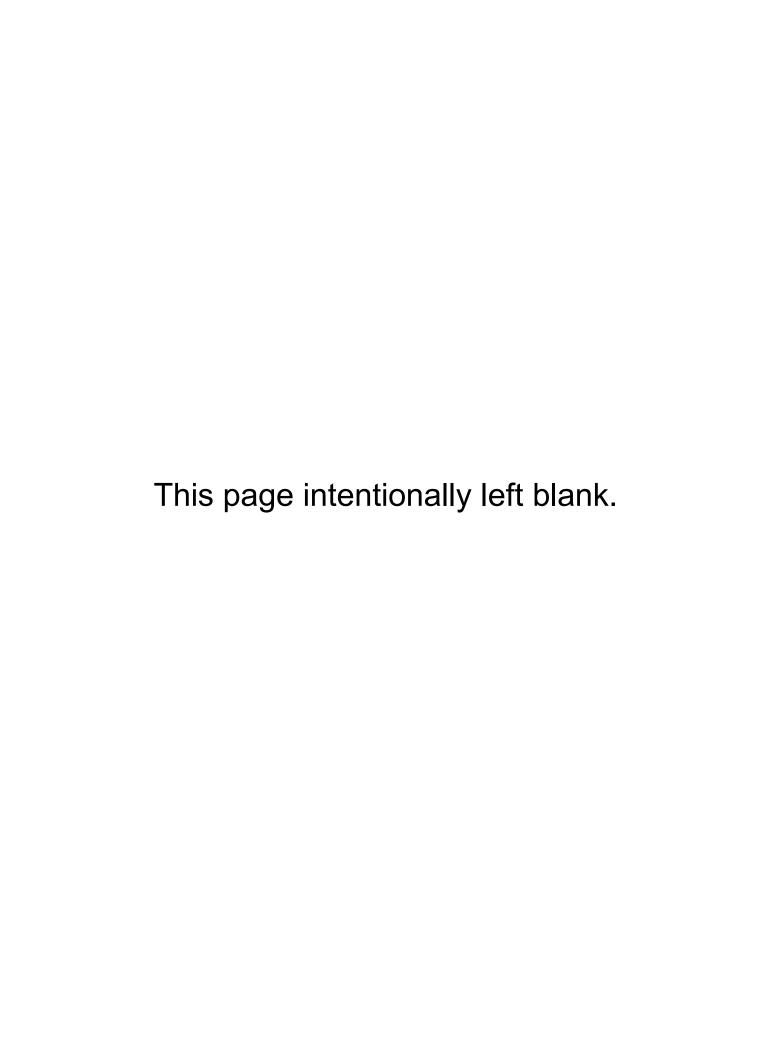
