Application for staff-assisted rate case in Duval County by

Neighborhood Utilities, Inc.

DOCKET NO. 150181-WU

On August 10, 2015, Neighborhood Utilities, Inc. (Neighborhood) filed an application with the Florida Public Service Commission (PSC or Commission) for a staff-assisted rate case. Neighborhood provides water service to approximately 441 customers in Duval County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Neighborhood's rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Neighborhood and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Neighborhood requesting a rate increase?

Neighborhood is requesting a rate increase in order to recover the cost of operating the utility and allow the company the opportunity to earn a fair rate of return on its investment.

3 When was Neighborhood's last approved rate increase?

Neighborhood's last approved rate increase was in 2010.

4 How much is the average monthly water bill for a residential customer using 5,000 gallons?

The average monthly water bill for a residential customer using 5,000 gallons is \$21.17.

Using PSC staff's preliminary recommended rates, how much would the average monthly water bill be for a residential customer using 5,000 gallons?

The average monthly water bill for a residential customer using 5,000 gallons would be \$33.27.
