Application for increase in water and wastewater rates in Levy County by

FIMC Hideaway, Inc.

DOCKET NO. 20170147-WS

On June 22, 2017, FIMC Hideaway, Inc. (FIMC) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water and wastewater rates. FIMC provides water and wastewater service to approximately 200 customers in Levy County. Prior to this case, FIMC operated separate water and wastewater plants for the Hideaway and Springside systems. These systems charged different rates for similar service. In April 2013, the utility completed the interconnection of its systems and formed them into a single water and wastewater system. The utility is requesting uniform rates.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for FIMC's rate request, the Commission staff will conduct a customer meeting to allow feedback about FIMC and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is FIMC requesting a rate increase?

FIMC is requesting a rate increase in order to recover the cost of operating the utility and allow the company the opportunity to earn a fair rate of return on its investment.

3 When was FIMC's last approved rate increase?

FIMC's last approved rate increase was in 1992.

4 How much is the current monthly water and wastewater bill for a residential customer using 2,000 gallons?

The current monthly water and wastewater bill for a residential customer is \$20.01 and \$17.15 for Hideaway customers and \$14.84 and \$29.37 for Springside customers.

5 Using staff's recommended rates, how much would the monthly water and wastewater bill be for a residential customer using 2,000 gallons?

Using staff's recommended rates, the monthly water and wastewater bill for a residential customer would be \$24.24 and \$33.11, respectively.
