### River Ranch Water Management, LLC

DOCKET NO. 20170219-WS

On October 10, 2017, River Ranch Water Management, LLC (River Ranch) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water and wastewater rates. River Ranch provides water and wastewater service in Polk County to approximately 65 residential customers and general service customers, including a chapel, a 367-unit recreational vehicle park, 192 condominium units, 119 mobile home park lots, and other resort properties.

#### QUESTIONS & ANSWERS

## 1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for River Ranch's rate request, the Commission staff will conduct a customer meeting to allow feedback about River Ranch and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

### 2 Why is River Ranch requesting a rate increase?

River Ranch is requesting a rate increase in order to recover the cost of operating the utility and allow the company the opportunity to earn a fair rate of return on its investment.

## 3 When was River Ranch's last approved rate increase?

River Ranch's last approved rate increase was in 2003.

4 How much are the current monthly water and wastewater bills for a residential customer of River Ranch?

The utility's current monthly bill for a residential customer of River Ranch is \$15.85 for water and \$17.16 for wastewater.

# 5 Using staff's recommended rates, how much would the monthly water and wastewater bill be for a residential customer of River Ranch?

Using staff's recommended rates, the monthly bill for a residential customer of River Ranch would be \$47.51 for water and \$39.35 for wastewater.
