Application for increase in water rates in Highlands County by

Country Walk Utilities, Inc.

On January 23, 2018, Country Walk Utilities, Inc. (Country Walk) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water rates. Country Walk provides water service in Highlands County to approximately 70 residential customers and one general service customer.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Country Walk's rate request, the Commission staff will conduct a customer meeting to allow feedback about Country Walk and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Country Walk requesting a rate increase?

Country Walk is requesting a rate increase in order to recover the cost of operating the utility and allow the company the opportunity to earn a fair rate of return on its investment.

3 When was Country Walk's last approved rate increase?

Country Walk has never had a rate case while under Commission jurisdiction.

4 How much is the current monthly water bill for a residential customer of Country Walk using 3,000 gallons?

The utility's current monthly water bill for a residential customer using 3,000 gallons is \$34.96.

5 Using staff's recommended rates, how much would the monthly water bill be for a residential customer of Country Walk using 3,000 gallons?

Using staff's recommended rates, the monthly bill for a residential customer of Country Walk using 3,000 gallons would be \$74.43.

6 What if I cannot attend the customer meeting or prefer not to speak? Are there other ways to comment on this case?
