

Application for increase in water and wastewater rates in Highlands County by

LP Waterworks, Inc.

DOCKET NO. 20180215-WS

On November 26, 2018, LP Waterworks, Inc. (LP) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water and wastewater rates. LP provides water service to approximately 440 residential customers and wastewater service to approximately 390 residential customers in Highlands County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for LP's rate request, the Commission staff will conduct a customer meeting to allow feed-back about LP and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is LP requesting a rate increase?

LP is requesting a rate increase in order to recover the cost of operating the utility and allow the company the opportunity to earn a fair rate of return on its investment.

3 When was LP's last approved rate increase?

LP's last approved rate increase was in 2016.

4 How much is the current monthly water and wastewater bill for a residential customer of LP using 3,000 gallons?

The utility's current monthly water and wastewater bill for a residential customer using 3,000 gallons is \$26.83 and \$32.19, respectively.

5 Using the utility's proposed rates, how much would the monthly water and wastewater bill be for a residential customer of LP using 3,000 gallons?

Using the utility's proposed rates, the monthly water and wastewater bill for a residential customer using 3,000 gallons would be \$38.09 and \$45.70, respectively.

6 What if I cannot attend the customer meeting or prefer not to speak? Are there other ways to comment on this case?
