

Application for increase in water rates in Lake County by

Lake Idlewild Utility Company

DOCKET NO. 20180216-WU

On November 26, 2019, Lake Idlewild Utility Company (Lake Idlewild) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water rates. Lake Idlewild provides service to approximately 75 water customers in Lake County.

QUESTIONS & ANSWERS

Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Lake Idlewild's rate request, the Commission staff will conduct a customer meeting to allow feedback about Lake Idlewild and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Lake Idlewild requesting a rate increase?

Lake Ildewild is requesting a rate increase in order to recover the cost of operating the utility and allow the company the opportunity to earn a fair rate of return on its investment.

3 When was Lake Idlewild's last approved rate increase?

Lake Idlewild's last approved rate increase was in 2016.

4 How much is the current monthly water bill for a residential customer using 3,000 gallons?

The utility's current monthly water bill for a residential customer using 3,000 gallons is \$22.42.

5 Using the utility's proposed rates, how much would the monthly water bill be for a residential customer using 3,000 gallons?

Using the utility's proposed rates, the monthly water bill for a residential customer using 3,000 gallons would be \$26.90.
