

Application for increase in wastewater rates in Brevard County by

TKCB, Inc.

DOCKET NO. 20180218-SU

On November 26, 2018, TKCB, Inc. (TKCB) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in wastewater rates. TKCB provides wastewater service to approximately 275 residential customers in Brevard County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for TKCB's rate request, the Commission staff will conduct a customer meeting to allow feedback about TKCB and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

$\mathbf{2}_{\text{crease?}}^{\text{Why is TKCB requesting a rate increase}}$

TKCB is requesting a rate increase to recover the cost of operating the utility and allow the company the opportunity to earn a fair rate of return on its investment.

3 When was TKCB's last approved rate increase?

TKCB's last approved rate increase was in 2012.

4 How much is the current monthly wastewater bill for a residential customer of TKCB using 6,000 gallons?

The utility's current monthly wastewater bill for a residential customer using 6,000 gallons is \$38.53.

5 Using staff's proposed rates, how much would the monthly wastewater bill be for a residential customer of TKCB using 6,000 gallons?

Using staff's proposed rates, the monthly wastewater bill for a residential customer using 6,000 gallons would be \$43.15.
