Application for increase in wastewater rates in Polk County by

West Lakeland Wastewater, LLC.

DOCKET NO. 20180202-SU

On October 30, 2018, West Lakeland Wastewater, LLC. (West Lakeleand) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in wastewater rates. West Lakeland provides wastewater service to approximately 315 residential customers in Polk County.

QUESTIONS & ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for West Lakeland's rate request, the Commission staff will conduct a customer meeting to allow feedback about West Lakeland and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is West Lakeland requesting a rate increase?

West Lakeland is requesting a rate increase to recover the cost of operating the utility and allow the company the opportunity to earn a fair rate of return on its investment.

When was West Lakeland's last approved rate increase?

West Lakeland's last approved rate increase was in 2014.

4 How much is the current monthly wastewater bill for a residential customer of West Lakeland using 4,000 gallons?

The utility's current monthly wastewater bill for a residential customer using 4,000 gallons is \$39.34.

5 Using staff's proposed rates, how much would the monthly wastewater bill be for a residential customer of West Lakeland using 4,000 gallons?

Using staff's proposed rates, the monthly wastewater bill for a residential customer using 4,000 gallons would be \$42.96.

6 What if I cannot attend the customer meeting or prefer not to speak? Are there other ways to comment on this case?
