### Deer Creek RV Golf & Country Club, Inc.

On March 25, 2019, Deer Creek RV Golf & Country Club, Inc. (Deer Creek) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water and wastewater rates. Deer Creek provides water and wastewater service to approximately 750 residential customers and 40 general service customers in Polk County.

#### QUESTIONS & ANSWERS

# 1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Deer Creek's rate request, the Commission staff will conduct a customer meeting to allow feedback about Deer Creek and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

## 2 Why is Deer Creek requesting a rate increase?

Deer Creek is requesting a rate increase to recover the cost of operating the utility and allow the company an opportunity to earn a fair rate of return on its investment.

# 3 When was Deer Creek's last approved rate increase?

Deer Creek has not had a staff-assisted rate case proceeding.

4 How much is the current monthly water and wastewater bill for a residential customer of Deer Creek using 2,000 gallons?

The utility's current monthly water and wastewater bill for a residential customer using 2,000 gallons is \$8.31 and \$22.50, respectively.

5 Using staff's recommended rates, how much would the monthly water and wastewater bill be for a residential customer of Deer Creek using 2,000 gallons?

Using staff's recommended rates, the monthly water and wastewater bill for a residential customer using 2,000 gallons would be \$30.44 and \$32.31, respectively.

6 What if I cannot attend the customer meeting or prefer not to speak? Are there other ways to comment on this case?
