

Application for increase in water and wastewater rates in Sumter County by

## The Woods Utility Company

DOCKET NO. 20190125-WS

On June 6, 2019, The Woods Utility Company (The Woods) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water and wastewater rates. The Woods provides water and wastewater service to approximately 60 residential customers and 1 general service customer, and approximately 50 wastewater only customers in Sumter County.

#### QUESTIONS & ANSWERS

# 1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for The Woods' rate request, the Commission staff will conduct a customer meeting to allow feedback about The Woods and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

### 2 Why is The Woods requesting a rate increase?

The Woods is requesting a rate increase to recover the cost of operating the utility and allow the company an opportunity to earn a fair rate of return on its investment.

# **3** When was The Woods' last approved rate increase?

The Woods has not had a staff-assisted rate case proceeding.

**4** How much is the current monthly water and wastewater bill for a residential customer of The Woods using 2,000 gallons?

The utility's current monthly water and wastewater bill for a residential customer using 2,000 gallons is \$32.27 and \$56.71, respectively.

**5** Using staff's recommended rates, how much would the monthly water and wastewater bill be for a residential customer of The Woods using 2,000 gallons?

Using staff's recommended rates, the monthly water and wastewater bill for a residential customer using 2,000 gallons would be \$41.96 and \$57.72, respectively.
