Application for a limited alternative rate increase in Marion County by

East Marion Utilities, LLC

DOCKET NO. 20200152-WS

On May 28, 2020, East Marion Utilities, LLC (East Marion or Utility) filed an application with the Florida Public Service Commission (PSC or Commission) for a limited alternative rate increase. East Marion provides water service to 106 and wastewater service to 94 customers in Marion County.

QUESTIONS & ANSWERS

1 Why is East Marion requesting a rate increase?

East Marion is requesting a rate increase to recover its share of increased common costs (such as office expense, salaries, and insurance) payable to its service company, FUS1. East Marion also seeks to recover its share of the costs for a new Compliance Technician position.

2 When was East Marion's last approved rate increase?

East Marion's rates were last approved by the Commission in a staff-assisted rate case in 2017

3 How much is the current monthly water and wastewater bill for a residential customer of East Marion using 4,000 gallons?

The Utility's current monthly water and wastewater bill for a residential customer using 4,000 gallons are \$23.49 and \$38.88, respectively.

4 Using the Utility's proposed rates, how much would the monthly water and wastewater bill be for a residential customer of East Marion using 4,000 gallons?

Using the Utility's proposed rates, the monthly water and wastewater bill for a residential customer using 4,000 gallons would be \$24.91 and \$40.69, respectively.

5 What if I wish to provide input on the proposed rate increase?
