



# Florida Public Service Commission **RATE CASE OVERVIEW**

Application for a limited alternative rate increase in Polk County by

## **Sunrise Water, LLC**

DOCKET NO. 20200152-WS

*On May 28, 2020, Sunrise Water, LLC (Sunrise or Utility) filed an application with the Florida Public Service Commission (PSC or Commission) for a limited alternative rate increase. Sunrise provides water service to approximately 257 customers in Polk County.*

### **QUESTIONS & ANSWERS**

#### **1 Why is Sunrise requesting a rate increase?**

Sunrise is requesting a rate increase to recover its share of increased common costs (such as office expense, salaries, and insurance) payable to its service company, FUS1. Sunrise also seeks to recover its share of the costs for a new Compliance Technician position.

#### **2 When was Sunrise's last approved rate increase?**

Sunrise's rates for water were last approved by the Commission in a staff-assisted rate case in 2016.

#### **3 How much is the current monthly water bill for a residential customer of Sunrise using 5,000 gallons?**

The Utility's current monthly water bill for a residential customer using 5,000 gallons is \$27.25.

#### **4 Using the Utility's proposed rates, how much would the monthly water bill be for a residential customer of Sunrise using 5,000 gallons?**

Using the Utility's proposed rates, the monthly water bill for a residential customer using 5,000 gallons would be \$32.80.
