## RATE CASE OVERVIEW

Application for a staff-assisted rate case in Lake County by

#### Lake Yale Utilities, LLC

DOCKET NO. 20200169-WS

On June 19, 2020, Lake Yale Utilities, LLC (Lake Yale or Utility) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water and wastewater rates. Lake Yale provides water and wastewater service to approximately 300 residential customers in Lake County.

#### QUESTIONS & ANSWERS

## 1 Why is Lake Yale requesting a rate increase?

Lake Yale is requesting a rate increase in order to recover the costs of purchasing a lawn mower and accompanying trailer, and to account for increased operating expenses.

## 2 When was Lake Yale's last approved rate increase?

Lake Yale has never had a staff-assisted rate case before the Commission.

3 How much is the current monthly water and wastewater bill for a residential customer of Lake Yale using 6,000 gallons?

The Utility's current monthly water and wastewater bill for a residential customer using 6,000 gallons is \$21.69 and \$27.48, respectively.

4 Using staff's preliminary recommended rates, how much would the monthly water and wastewater bill be for a residential customer of Lake Yale using 6,000 gallons?

Using staff's preliminary recommended rates, the monthly water and wastewater bill for a residential customer using 6,000 gallons would be \$36.01 and \$62.74, respectively.

## 5 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Lake Yale's rate request, Commission staff will conduct a virtual customer meeting to allow feedback about Lake Yale and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.
