Application for staff-assisted rate increase in water rates in Lake County by

### Brendenwood Waterworks, Inc.

DOCKET NO. 20210055-WU

On March 16, 2021, Brendenwood Waterworks, Inc. (Brendenwood or Utility) filed an application with the Florida Public Service Commission (PSC or Commission) for an increase in water rates. Brendenwood provides service to approximately 60 water customers in Lake County.

#### QUESTIONS & ANSWERS

## 1 Why is Brendenwood requesting a rate increase?

Brendenwood is requesting a rate increase to recover the cost of operating the Utility and allow the company an opportunity to earn a fair rate of return on its investment.

## **2** When was Brendenwood's last approved rate increase?

Brendenwood's last approved rate increase was in 2010 while under the name of Brendenwood Water System, Inc. The Utility also had an index rate increase effective June 9, 2019.

## 3 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Brendenwood's rate request, Commission staff will conduct a virtual customer meeting to allow feedback about Brendenwood and the rate-setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

To speak at the virtual customer meeting, a customer must sign up via the PSC's online registration form, which will be available at www.FloridaPSC.com under the Hot Topics section on the home page. Customers without internet access can sign up to speak by calling the

PSC at (850) 413-7080. Registration will open beginning October 6, 2021 at 9:00 a.m., and the deadline to sign up is noon **two business days** prior to the meeting.

One day prior to the meeting, speakers will be provided further instructions from PSC staff on how to participate.

# 5 How much is the current monthly bill for a residential customer of Brendenwood using 4,000 gallons?

The Utility's current monthly bill for a residential customer of Brendenwood using 4,000 gallons is \$21.19.

6 Using staff's preliminary recommended rates, how much would the monthly bill be for a residential customer of Brendenwood using 4,000 gallons?

Using staff's preliminary recommended rates, the monthly bill for a residential customer of Brendenwood using 4,000 gallons would be \$24.84.

# 7 Who provides legal representation for customers in utility related matters before the Public Service Commission?

The Office of Public Counsel was established by the Florida Legislature to advocate on behalf of you and the other utility consumers before the Commission and other state and federal regulatory authorities. The Public Counsel is independent from the Commission, and accountable only to the people of the state of Florida through the Florida Legislature.
