Application for a limited alternative rate increase in Highlands County by

Country Walk Utilities, Inc.

DOCKET NO. 20210182-WU

On , November 16, 2021, Country Walk Utilities, Inc. (Country Walk or Utility) filed an application with the Florida Public Service Commission (PSC or Commission) for a limited alternative rate case. Country Walk provides service to approximately 70 residential water customers and one general service water customer in Highlands County.

QUESTIONS & ANSWERS

1 Why is Country Walk requesting a rate increase?

Country Walk is requesting a rate increase due to under earnings as a result of a decrease in revenues, increase in operating expenses, and an increase in Highlands County taxes.

2 When was Country Walk's last approved rate increase?

Country Walk's last approved rate increase for water was in 2018.

3 How much is the current monthly water bill for a residential customer of Country Walk using 3,000 gallons?

The Utility's current monthly water bill for a residential customer of Country Walk using 3,000 gallons is \$69.52.

4 Using the Utility's proposed rates, how much would the monthly water bill be for a residential customer of Country Walk using 3,000 gallons?

Using the Utility's proposed rates, the monthly water bill for a residential customer using 3,000 gallons would be \$75.22.

5 What if I wish to provide input on the proposed rate increase?
