On February 11, 2022, CHC VII, Ltd. (CHC or Utility) filed an application for an increase in water and wastewater rates with the Florida Public Service Commission (PSC or Commission). CHC is a Class C water and wastewater utility serving 885 residential water customers and 872 residential wastewater customers in Polk County.

Questions & Answers

Why is CHC requesting a rate increase?

CHC is requesting a rate increase to recover the cost of operating the Utility and allow the company an opportunity to earn a fair rate of return on its investment.

2 When was CHC's last approved rate increase?

CHC filed a limited proceeding rate case for its water system in 2019.

3 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process of CHC's rate request, Commission staff will conduct a virtual customer meeting to allow feedback about CHC's quality of service and the rate setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

To speak at the virtual customer meeting, a customer must sign up via the PSC's online registration form, which will be available at <u>www.FloridaPSC.com</u>, under the "Hot Topics" heading on the home page. Customers without internet access can sign up to speak by calling the PSC at (850) 413-7080. Registration will open beginning October 19, 2022 at 9:00 a.m., and the deadline to sign up is October 31, 2022 at noon.

One day prior to the meeting, speakers will be provided further instructions from PSC staff on how to participate.

How much are the current and proposed monthly water and wastewater bills for a CHC residential customer using 8,000 gallons?

The current monthly water and wastewater bills for a customer using 8,000 gallons are \$17.86 and \$23.62. The proposed monthly water and wastewater bills would be \$22.60 and \$35.88.

8 Who provides legal representation for customers in utility related matters before the Public Service Commission?
