

# Florida Public Service Commission RATE CASE OVERVIEW

#### November 2022

Application for increase in water and wastewater rates in Polk County by S.V. Utilities, Ltd.

DOCKET NO.20220035-WS

On February 11, 2022, S.V. Utilities, Ltd. (S.V. or Utility) filed an application for an increase in water and wastewater rates with the Florida Public Service Commission (PSC or Commission). S.V. is a Class C water and wastewater utility serving 707 residential and 6 general service customers in Polk County.

#### **Questions & Answers**

#### ■ Why is S.V. requesting a rate increase?

S.V. is requesting a rate increase to recover the cost of operating the Utility and allow the company an opportunity to earn a fair rate of return on its investment.

# **2** When was S.V.'s last approved rate increase?

S.V.'s last rate case was in 2014.

## 3 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process of S.V.'s rate request, Commission staff will conduct a virtual customer meeting to allow feedback about S.V.'s quality of service and the rate setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

To speak at the virtual customer meeting, a customer must sign up via the PSC's online registration form, which will be available at <a href="https://www.FloridaPSC.com">www.FloridaPSC.com</a>, under the "Hot Topics" heading on the home page. Customers without internet access can sign up to speak by calling the PSC at (850) 413-7080. Registration will open beginning October 20, 2022 at 9:00 a.m., and the deadline to sign up is November 1, 2022 at noon.

One day prior to the meeting, speakers will be provided further instructions from PSC staff on how to participate.

# 5 How much are the current and proposed monthly water and wastewater bills for an S.V. residential customer using 4,000 gallons?

The current monthly water and wastewater bills for a customer using 4,000 gallons are \$9.58 and \$17.05. The proposed monthly water and wastewater bills would be \$17.32 and \$26.54.
