

# Florida Public Service Commission RATE CASE OVERVIEW

#### November 2022

Application for increase in water and wastewater rates in Polk County by Anglers Cove West, Ltd.

DOCKET NO.20220032-WS

On February 11, 2022, Anglers Cove West, Ltd. (Anglers Cove or Utility) filed an application for an increase in water and wastewater rates with the Florida Public Service Commission (PSC or Commission). Anglers Cove is a Class C water and wastewater utility serving 344 residential and 6 general service customers in Polk County.

#### **Questions & Answers**

## 1 Why is Anglers Cove requesting a rate increase?

Anglers Cove is requesting a rate increase to recover the cost of operating the Utility and allow the company an opportunity to earn a fair rate of return on its investment.

### When was Anglers Cove's last approved rate increase?

Anglers Cove's last rate case was in 2008

## 3 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process of Anglers Cove's rate request, Commission staff will conduct a virtual customer meeting to allow feedback about Anglers Cove's quality of service and the rate setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

To speak at the virtual customer meeting, a customer must sign up via the PSC's online registration form, which will be available at <a href="https://www.FloridaPSC.com">www.FloridaPSC.com</a>, under the "Hot Topics" heading on the home page. Customers without internet access can sign up to speak by calling the PSC at (850) 413-7080. Registration will open beginning October 20, 2022 at 9:00 a.m., and the deadline to sign up is November 1, 2022 at noon.

One day prior to the meeting, speakers will be provided further instructions from PSC staff on how to participate.

# 5 How much are the current and proposed monthly water and wastewater bills for an Anglers Cove residential customer using 4,000 gallons?

The current monthly water and wastewater bills for a customer using 4,000 gallons are \$31.37 and \$30.09. The proposed monthly water and wastewater bills would be \$47.42 and \$51.35.
