Application for increase in water and wastewater rates in Polk County by

Hidden Cove, Ltd.

DOCKET NO.20220034-WS

On February 11, 2022, Hidden Cove, Ltd. (Hidden Cove or Utility) filed an application for an increase in water and wastewater rates with the Florida Public Service Commission (PSC or Commission). Hidden Cove is a Class C water and wastewater utility serving 122 residential customers, 3 general service water customers, and 1 general service customer for wastewater in Polk County.

Questions & Answers

1 Why is Hidden Cove requesting a rate increase?

Hidden Cove is requesting a rate increase to recover the cost of operating the Utility and allow the company an opportunity to earn a fair rate of return on its investment.

2 When was Hidden Cove's last approved rate increase?

Hidden Cove's last staff-assisted rate case was in 2007.

3 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process of Hidden Cove's rate request, Commission staff will conduct a virtual customer meeting to allow feedback about Hidden Cove's quality of service and the rate setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

To speak at the virtual customer meeting, a customer must sign up via the PSC's online registration form, which will be available at www.FloridaPSC.com, under the "Hot Topics" heading on the home page. Customers without internet access can sign up to speak by calling the PSC at (850) 413-7080. Registration will open beginning October 19, 2022 at 9:00 a.m., and the deadline to sign up is October 31, 2022 at noon.

One day prior to the meeting, speakers will be provided further instructions from PSC staff on how to participate.

4 What if I cannot attend the virtual customer meeting or prefer not to speak? Are there other ways to comment on this case?

5 How much are the current and proposed monthly water and wastewater bills for a Hidden Cove residential customer using 6,000 gallons?

The current monthly water and wastewater bills for a customer using 6,000 gallons are \$20.31 and \$35.08. The proposed monthly water and wastewater bills would be \$44.22 and \$51.14.
