

Florida Public Service Commission RATE CASE OVERVIEW

May 2023

Application for a limited alternative rate increase in Manatee County by

Heather Hills Utilities, LLC

DOCKET NO. 20220185-WS

On November 7, 2022, Heather Hills Utilities, LLC (Heather Hills) filed an application for an alternative rate increase (LARI) to recover the incremental increase over the amount approved in the utility's last rate proceeding. Heather Hills is a Class C water and wastewater utility providing service to 352 residential customers and one general service customer in Manatee County. The utility is operated under Florida Utility Services 1, LLC (FUS1), a service company.

Questions & Answers

1 Why is Heather Hills requesting a rate increase?

Heather Hills is requesting a rate increase to recover the incremental increase in operating costs over the amount approved in the utility's last rate proceeding.

2 When was Heather Hill's last approved rate increase?

Heather Hills 's last rate case was approved in 2020. However, the utility has had four price index rate adjustments.

3 What if I wish to provide input on the proposed rate increases?

4 How much is the current and proposed quarterly water bill for a Heather Hills residential customer using 4,000 gallons?

The current quarterly water bill for a Heather Hills customer using 4,000 gallons is \$50.58. The proposed quarterly water bill would be \$60.70.

5 How much is the current and proposed quarterly wastewater bill for a Heather Hills residential customer using 4,000 gallons?

The current quarterly wastewater bill for a Heather Hills customer using 4,000 gallons is \$78.56. The proposed quarterly wastewater bill would be \$90.35.


