

Florida Public Service Commission RATE CASE OVERVIEW

Application for a limited alternative rate increase in Pasco County by

Holiday Gardens Utilities, LLC (Holiday Gardens or Utility)

DOCKET NO. 20220185-WS

On November 7, 2022, Holiday Gardens Utilities, LLC filed an application for a alternative rate increase (LARI) to recover the incremental increase over the amount approved in the utility's last rate proceeding. Holiday Gardens is a Class C water utility serving 449 residential customers and eight general service customer in Pasco County. The utility is operated under Florida Utility Services 1, LLC (FUS1), a service company.

Questions & Answers

1 Why is Holiday Gardens requesting a rate increase?

Holiday Gardens is requesting a rate increase to recover the incremental increase in operating costs over the amount approved in the utility's last rate proceeding.

2 When was Holiday Gardens last approved rate increase?

Holiday Garden 's last rate case was approved in 2017. However, the utility has had price index rate adjustments.

3 What if I wish to provide input on the proposed rate increase?

4 How much is the current and proposed monthly water bill for a Holiday Gardens residential customer using 4,000 gallons?

The current monthly water bill for a Holiday Garden customer using 4,000 gallons is \$27.02. The proposed monthly water bill would be \$32.44.
