

# Florida Public Service Commission RATE CASE OVERVIEW

Application for a limited alternative rate increase in Polk County by

## McLeod Gardens Utilities, LLC

#### DOCKET NO. 20220185-WS

On November 7, 2022, McLeod Gardens Utilities, LLC (McLeod) filed an application for a limited alternative rate increase (LARI) to recover the incremental increase in operating costs over the amount approved in the utility's last rate proceeding. McLeod is a Class C utility providing water service in Polk County to 99 residential customers and 1 general service customer. The utility is operated under Florida Utility Services 1, LLC (FUS1), a service company.

#### Why is McLeod requesting a rate increase?

McLeod is requesting a rate increase to recover the incremental increase in operating costs over the amount approved in the utility's last rate proceeding.

#### When was McLeod's last approved rate increase?

McLeod's last rate case was approved in 2021. However, the utility has had two price index rate adjustments.

#### How much are the current and proposed monthly water bills for a McLeod residential customer using over 5,000 gallons?

The current monthly water bill for a McLeod residential customer using 5,000 gallons is \$39.40. The proposed monthly water bill would be \$45.29.
