Petition for Rate Increase

Florida Public Utilities Company

DOCKET NO. 20240099-EI

On August 22, 2024, Florida Public Utilities Company (FPUC or Utility) filed an application with the Florida Public Service Commission (Commission or PSC) for a rate increase. FPUC's electric division currently provides electric service to 33,100 customers in two distinct service areas; the Northeast Division (Fernandina Beach, Florida) and the Northwest Division (Marianna, Florida).

QUESTIONS & ANSWERS

1. Why is FPUC requesting a rate increase?

FPUC is requesting a rate increase to recover the cost of operating the Utility and allow FPUC an opportunity to earn a fair rate of return on its investment.

2. When was FPUC's last approved rate increase?

FPUC's last rate case was in 2014 (Docket No. 20140025-EI).

3. Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process of FPUC's rate increase request, Commission staff will conduct inperson service hearings to allow feedback about FPUC's quality of service and the rate setting process. Comments will be reviewed before the Commission reaches a decision. Commissioners will attend and participate during the service hearings.

Customers who wish to speak at the in-person service hearings may register upon arrival at the venues. All persons who wish to comment in-person are urged to appear promptly at the scheduled times because the service hearings may be adjourned early if no customers are present to testify or when those present have testified. Please note that the order in which customers will speak is based on the order in which they sign-up. If you have questions about the sign-up process, please call (850) 413-7080.

6. How much is the interim and proposed monthly bill for a FPUC residential customer using 1,000 kWh?

The interim monthly bill for a FPUC customer using 1,000 kWh is \$169.06. The proposed monthly bill for a FPUC customer using 1,000 kWh would be \$161.66.

7. Who provides legal representation for customers in utility related matters before the Public Service Commission?

The Office of Public Counsel was established by the Florida Legislature to advocate on behalf of you and the other utility customers before the Commission and other state and federal regulatory authorities. The Office of Public Counsel is independent from the Commission, and accountable only to the people of the State of Florida through the Florida Legislature. 
