



# Florida Public Service Commission **RATE CASE OVERVIEW**

JANUARY 2026

Application for staff-assisted rate case in Lake County by  
**Water Oak Utility**

DOCKET NO. 20250088 – WU

On June 23, 2025, Sun Communities Finance, LLC d/b/a Water Oak Utility (Water Oak) filed an application with the Florida Public Service Commission (Commission or FPSC) for a staff-assisted rate case. Water Oak provides water service to 1,265 residential and 17 general service customers in Lake County.

## QUESTIONS & ANSWERS

### 1. Why is Water Oak requesting a rate increase?

Water Oak is requesting a rate increase to recover the cost of operating the Utility and allow the company an opportunity to earn a fair rate of return on its investment.

### 2. When was Water Oak's last approved rate case?

Rate base was established for Water Oak in 1993.

### 3. Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process of Water Oak's request, Commission staff will conduct a virtual customer meeting to allow feedback about Water Oak's quality of service and the rate setting process. Comments will be reviewed before the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

Registration will be available beginning January 7, 2026 at 9 a.m. EDT, and close at noon on January 20, 2026. One day prior to the meeting, customers who signed up to speak will be provided further instructions from FPSC staff on how to participate.

All customers who register to present comments at the meeting are urged to call in promptly at the scheduled meeting time, because the meeting may be adjourned early if no customers are present.

The current monthly water bill for a residential customer of Water Oak using 3,000 gallons is \$8.95.

### 7. How much would the monthly water bill be for a residential customer of Water Oak using 3,000 gallons?

The monthly bill for a residential customer of Water Oak using 3,000 gallons at the proposed rate would be \$37.01.

### 9. Who provides legal representation for customers in utility related matters before the FPSC?

FPSC staff is scheduled to file a recommendation with the Commission on March 19, 2026. The Commissioners are expected to vote on the recommendation at the April 7, 2026 Commission Conference.
