**2. Number of meters served in calendar year 2022**

Tri-County Electric Cooperative provided electric service to (110) customer-owned renewable generation interconnections for the reporting period ending December 31, 2021.

**3. Total kW capacity served in calendar year 2022**

The total kW capacity of the customer-owned renewable generation interconnections served by Tri-County Electric was 2298.23 kW for the reporting period ending December 31, 2022.

**4. Total kWh received by interconnected customers from the electric utility by month and by year for the calendar year 2022.**

The interconnected renewable generation customers received and purchased a total of 5,519,591 kWh from Tri-County Electric Cooperative during the reporting period ending December 31, 2022.

6. **Total energy payments made to interconnected customers for customer-owned renewable generation delivered to the electric utility for the calendar year 2022, along with the total payments made since the implementation of this rule.**

Tri-County Electric Cooperative has paid to the customer-owned renewable generation interconnections for electric received a total of \$79,221.73 for the reporting period ending December 31, 2022. Tri-County Electric Cooperative first interconnection service was in March, 2009 and has paid a total of \$215,467.64 for electricity received since the implementation of this rule.

7. **For each individual customer-owned renewable general interconnection:**

1. **Renewable technology utilized:**

The only source of customer-owned renewable generation technology utilized with interconnects thus far at Tri-County Electric Cooperative has been photovoltaic system.

2. **Gross power rating:**

The 110 customer-owned renewable generation interconnections at Tri-County Electric Cooperative have a total gross power rating of 2298.23 kW (DC) during the reporting period ending on December 31, 2022.

3. **Geographic location by county; and**

Tri-County Electric Cooperative currently has interconnections with customer-owned renewable generation in three Florida counties in our service area. There are (31) interconnects in Jefferson County, Florida, (50) interconnects in Madison County, Florida and (28) interconnects in Taylor County, Florida, and (1) interconnects in Dixie County.

4. **Date interconnected.**

Tri-County Electric Cooperative has (106) customers participating in customer-owned renewable generation ending on December 31, 2022. The name, date connected and location of these customers are as follows:
