Dear Karen Web,

In response to your data request requiring that all Electric Investor Owned Utilities (IOUs) complete and return RPS Data forms 1-6, Florida Public Utilities Co., is unable to fully process this request. Enclosed is an email correspondence between FPUC and the PSC inquiring as to how non-generating electric utilities are to respond to the data requests as well as the response received back from the PSC. Unfortunately, FPUC is unable to accurately respond to RPS data since we do not have access to the electricity generation data required in the data request.

As a non-generating utility who primarily serves as an electric distributor, FPUC purchases it's electricity from two electric companies, JEA and Gulf Power. Please defer to the JEA's data request submission for electric generation data for our customers in Nassau County, and defer to Gulf Power's data request submission for electric generation data for our customers in Jackson, Liberty & Calhoun Counties.

If there is any other way FPUC can provide additional information that will prove to be helpful in developing a Renewable Portfolio Standard for the State of Florida, FPUC will be to be happy to be of assistance.
