Section 364.386, Florida Statutes, requires the Commission to gather data from the telecommunications industry to prepare its annual report to the Florida Legislature on telecommunications competition. Please note that the bulk of the request now simply requires the submission of a copy of your company's Broadband Data Collection System (formerly Form 477) line data with the most current calendar year data as submitted to the FCC by March 1, 2024.

Please respond to the data request concurrently with your company's filing at the FCC, or as soon thereafter as practicable, but in no event later than April 15, 2024, as established by Section 364.386(1)(b), Florida Statutes. The data request has been updated for the 2024 Local Competition Report and previous versions of the data request should not be used. If you were not providing local non-VoIP services as of December 31, 2023, please indicate this on the data request questionnaire.

Responses for which your company is claiming confidentiality must be filed with the Office of Commission Clerk together with a statement that the company is making a confidentiality claim.
